# **DFE Guidelines**

We have recently had a significant number of requests for critical worker places in school. I would like to remind you that the government guidance tells us that if you are working from home you must keep your child at home. This is to keep both families and staff as safe as possible. Please understand that on some occasions I have had to refuse places in school based on the fact a parent is working from home. Please appreciate that these are not easy decisions to make and are guided solely by DFE guidance. As a result of this can I request that you only contact school if your working situation has changed, and you are no longer working from home or able to keep your child safe at home.

## February Half Term- School closed to all pupils

The Department for Education confirmed that schools will close to all pupils during February half term. Under the first lockdown, schools were asked to remain open during the holiday period but this is no longer the case. We are sorry for any inconvenience this causes to parents/carers whose work is critical to the COVID-19 response.

## Contact tracing over the February half-term

Whilst schools are closed to all pupils during February half term, schools have been asked to undertake a role in contact tracing for pupils and staff. We will provide details of this in a subsequent letter and also on the Coronavirus section of the website.

# **Rapid Testing for School Staff**

Rapid testing kits arrived last week in school so we are now offering testing to school staff (started on 31.1.21). This should help to reduce the rate of transmission from those being tested that have no symptoms but are infectious. Naturally, we will follow the procedures to carry out testing and communicate regularly with you if there are positive cases in school.

During the pandemic, school governance has remained an integral part to the running of our successful school. The Governing body continue to meet virtually on a regular basis and the governors are a continual source of support during this challenging period. During my headship I have been fortunate to have had a supportive chair of governors.
